A Town of Sheboygan Town Board meeting was held on Monday, August 1, 2016 in open session at the Town of Sheboygan Town Hall, 1512 No. 40<sup>th</sup> Street, Sheboygan, Wisconsin 53081, Sheboygan County, Wisconsin.

- 1) Chairman Hein called the meeting to order and introductions of Board and Staff were made.
- 2) Agenda-**Motion Wagner, second Gumm to approve the agenda for August 1, 2016 as presented. Motion carried.**
- 3) Approval of Minutes of July 19, 2016-**Motion Schwinn, second Gumm to approve the minutes of July 19, 2016 as presented. Motion carried.**
- 4) Entrance Signs & Logo-Katie Pauls Schauer, a graphic designer, was present with several concept designs for a logo sign. After discussion of design, colors, etc. the Board narrowed down their favorites and eliminated those they were less likely to incorporate into any signage. Schauer will forward redesigned samples via e-mail for the next Board meeting using the “established” date in a circular pattern and showing a variety of fonts. This item will be placed on the next Town Board agenda.
- 5) Hiring of additional staff-Bill Blashka and John Witters explained that they interviewed the top three candidates for the Public Works Department opening. Blashka and Witters both recommended the hiring of Steven Norton. **Motion Schwinn, second Wagner to offer the Public Works Department job opening to Steven Norton at a starting wage of \$18.00 with review in 6 months. Motion carried.**
- 6) Adjourn- **Motion Schwinn, second Wagner to adjourn the meeting at 6:30 pm. Motion carried.**
